***“América Móvil informs about legal actions exercised against resolution of the Instituto Federal de Telecomunicaciones”***

**Mexico City, Mexico, April 1, 2014. América Móvil, S.A.B. de C.V. (“AMX”) (BMV: AMX; NYSE: AMX; NASDAQ: AMOV; LATIBEX: XAMXL)**, informs that today it has filed an injunction (*juicio de amparo*), against the resolution issued by the Federal Telecommunications Institute (*Instituto Federal de Telecomunicaciones*, or “*IFT*”), through which said institute determined as “preponderant economic agent” (*agente económico preponderante*), in the telecommunications market in Mexico to an alleged economic interest group comprised by AMX, Teléfonos de México, S.A.B. de C.V. (“*Telmex*”), Radiomóvil Dipsa, S.A. de C.V. (“*Telcel*”), Grupo Carso, S.A.B. de C.V., and Grupo Financiero Inbursa, S.A.B. de C.V., imposing certain specific asymmetrical regulations.

AMX has been informed that its operating subsidiaries Telmex y Telcel have also filed an injunction (*juicio de amparo*), against the aforesaid resolution.
