- (2) Represents shares of Class A Common Stock that were automatically added to the shares authorized for issuance under the 2011 Plan on January 1, 2019 pursuant to an "evergreen" provision contained in the 2011 Plan. Pursuant to such provision, on January 1st of each year commencing in 2012 and continuing through and including January 1, 2021, the number of shares authorized for issuance under the 2011 Plan is automatically increased by four percent (4%) of the aggregate number of shares of Zynga's capital stock outstanding on December 31st of the preceding calendar year, or such lesser number of shares that may be determined by Zynga's Board of Directors.

EXPLANATORY NOTE

Zynga is filing this Registration Statement for the purpose of registering (i) an additional 34,444,440 shares of Class A Common Stock to be issued pursuant to the 2011 Plan and (ii) an additional 17,222,220 shares of Class A Common Stock to be issued pursuant to the 2011 ESPP. These shares being registered pursuant to this Registration Statement are the same class as other securities for which earlier registration statements relating to the 2011 Plan and the 2011 ESPP were filed with the Securities and Exchange Commission (the "SEC") on December 15, 2011 (File No. 333-178529), August 17, 2012 (File No. 333-183406), May 2, 2013 (File No. 333-188282), November 7, 2014 (File No. 333-199959), August 7, 2015 (File No. 333-206185), May 6, 2016 (File No. 333-211201), May 5, 2017 (File No. 333-217752) and February 20, 2018 (File No. 333-223109) (collectively, the "Prior Registration Statements"). In accordance with General Instruction E of Form S-8, the contents of the Prior Registration Statements are incorporated herein by reference and made part of this Registration Statement, except as amended hereby.
