Item 1. SECURITY AND ISSUER

This Amendment No. 9 relates to the Schedule 13D filed on April 5, 2002 in connection with the ownership by Asset Value Fund Limited Partnership ("Asset Value") of the common stock, \$.01 par value per share ("Shares") of The Dewey Electronics Corporation, a New York corporation (the "Company" or "Dewey"). The capitalized terms used in the Amendment, unless otherwise defined, shall have the same meaning as in the original Schedule 13D.

Item 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.

Item 3 is hereby amended by the addition of the following:

Since the date of the last filing, Asset Value has sold 19,800 Shares for aggregate sales proceeds of \$112,610.28, net of brokerage commissions.

Item 5. INTEREST IN SECURITIES OF THE ISSUER

Item 5 is hereby amended by the addition of the following:

(a) As of the close of business on January 26, 2005, Asset Value beneficially owned 122,000 Shares, representing 8.97% of Shares reported as outstanding in the Company's Form 10-Q for the quarter ended September 30, 2004.
