Mr. Madison and Mr. Steinberg (together, the Managers) are the managers of Mast Capital Management, LLC (Capital), which is the investment adviser of Mast Credit Opportunities I Master Fund Limited (the Fund) and is the general partner and investment adviser of Mast OC I Master Fund L.P. (the LP). The Reporting Persons have entered into a Joint Filing Agreement, dated as of the date hereof, a copy of which is filed with this Schedule 13G as Exhibit 1 (which is incorporated herein by reference), pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k) under the Act.

Item 4. Ownership.

As of December 31, 2009, the Reporting Persons, in the aggregate, beneficially own 1,238,825 shares of Common Stock of the Issuer, representing approximately 12.4% of such class of securities. The beneficial ownership of each Reporting Person is as follows: (i) the LP beneficially owns 400,995 shares of Common Stock of the Issuer representing approximately 4.0% of such class, (ii) the Fund beneficially owns 837,830 shares of Common Stock of the Issuer representing approximately 8.4% of such class and (iii) Capital, as the investment adviser to the Fund and the investment adviser and general partner of the LP, and Mr. Madison and Mr. Steinberg, as the managers of Capital, each beneficially owns 1,238,825 shares of Common Stock of the Issuer representing 12.4% of such class. The percentage of the Common Stock beneficially owned by each Reporting Person is based on a total of 9,986,202 shares the Common Stock of the Issuer outstanding as of July 31, 2009 as reported in the most recent quarterly report of the Issuer on Form 10-Q for the quarterly period ended June 30, 2009.

The Fund and the LP each have the power to vote and dispose all of the shares of Common Stock beneficially owned by such entity (as described above). Capital, as the investment adviser of the Fund and the investment adviser and general partner of the LP, has the authority to vote and dispose of all of the shares of Common Stock beneficially owned by the Fund and the LP. Each of the Messrs. Madison and Steinberg, by virtue of his position as manager of Capital, has the authority to vote and dispose of all of the shares of Common Stock beneficially owned by the Fund and the LP.
