(1) Acquisition Sub Inc., a Rhode Island corporation and an indirect wholly-owned subsidiary of Essilor, at the effective time of the merger, each outstanding share of the Company's Class A Common Stock, par value \$1.00 per share, was converted into the right to receive \$21.50 in cash.
