Item 1.01 Entry into a Material Definitive Agreement

On June 1, 2010, certain wholly-owned subsidiaries of Marchex, Inc. (the <u>Company</u>), namely MDNH, In<u>c. (MD</u>NH) and MDNH International Ltd. (<u>MDNH International</u>), entered into Amendment No. 3 (the <u>Amendment</u>) to the Yahoo! Publisher Network Service Order #1-8196149 effective July 1, 2007 (the <u>Agreement</u>), as amended, by and between MDNH, MDNH International, Yahoo! Inc., as successor in interest to Overture Services, Inc. and Yahoo! Sarl, as successor in interest to Overture Search Services (Ireland) Limited. The Amendment extends the maturity of the Agreement through September 30, 2010 and amends certain termination obligations and non-renewal notice periods.

The above summary is qualified in its entirety by reference to the Amendment, a copy of which will be filed as an exhibit to the Company s next applicable periodic report or registration statement.
