- (1) 3,308 previously owned shares having a market value of \$13.38 per share were delivered in payment of the option price of \$6.81 per share for 6500 shares acquired pursuant to the exercise of an option granted under the 2002 Performance Plan (the "2002 Plan").
6500 shares were acquired pursuant to the exercise of an option granted under the 2002 Plan. The option purchase price was paid in accordance with the 2002 Plan in the form of 3308 shares valued in accordance with the 2002 Plan. In addition, 1028 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant.
- (2) 193 previously owned shares having a market value of \$13.38 per share were delivered in payment of the option price of \$7.94 per share for 326 shares acquired pursuant to the exercise of an option granted under the 2002 Performance Plan (the "2002 Plan").
326 shares were acquired pursuant to the exercise of an option granted under the 2002 Plan. The option purchase price was paid in accordance with the 2002 Plan in the form of 193 shares valued in accordance with the 2002 Plan. In addition, 43 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant. As a result of the transactions reported on this form, the reporting person's direct ownership of common stock increased by 2,254 shares.
- (3) Total number of shares of common stock allocated to the account of the reporting person in a Trust established under Goodyear's Employee Savings Plan for Salaried Employees, a 401(k) Plan (the "Savings Plan"), as of the date of this statement as reported by the Plan Trustee.
- (4) The shares are held by a nominee of The Northern Trust Company, the Savings Plan Trustee.
