 - (1) Each restricted stock unit (RSU) represents the right to receive, following vesting, one Logitech share. The RSUs vest and convert into shares in four equal annual installments. The first installment vests on April 15, 2016, and the next three vest on April 15, 2017, April 15, 2018 and April 15, 2019.
 - (2) In an exempt disposition to the issuer under rule 16b-3(e), the recipient remitted shares to the issuer in connection with the satisfaction of tax withholding obligations arising out of the vesting of shares with respect to previously reported restricted stock units.
 - (3) The reported amount represents the purchase price on the SIX Swiss Exchange of CHF 13.75, as converted into U.S. dollars at the exchange rate of 1 CHF to U.S. \$1.02872, as in effect on April 15, 2015.
