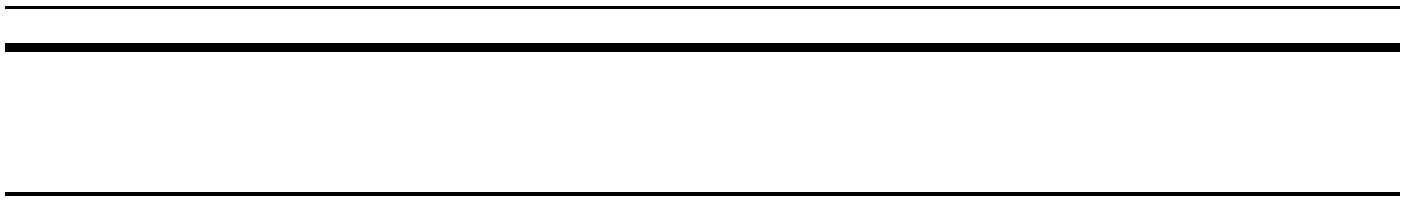

Item Submission of Matters to a Vote of Security Holders

The annual meeting of stockholders of Interactive Brokers Group, Inc. (the "Company") was held on April 25, 2013.

The stockholders voted on proposals to elect directors to the Company's Board of Directors (the "Board"), to approve the Company's executive compensation and to ratify the appointment of Deloitte & Touche LLP as independent auditor.

All nominees for election to the Board were elected for a one year term expiring at the annual meeting of stockholders in the following year. Each director will hold office until his successor has been elected and qualified or until the director's earlier resignation or removal.

The number of votes cast for or against and the number of abstentions with respect to each proposal is set forth below. The Company's independent inspector of election reported the vote of the stockholders as follows:

Stockholders approved the appointment of Deloitte & Touche LLP as the Company's independent registered public accounting firm for the year ending December 31, 2013, by a vote of 392,751,129 for; 211,887 against; and 12,856 abstentions.

Stockholders approved executive compensation levels by a vote of 386,085,688 for; 161,685 against; 190,268 abstentions; and 6,538,231 broker non-votes.
