1,902,900 of the Reported Shares are held by the Hodges Fund, 80,000 of the Reported Shares are held by the Hodges Small Cap Fund, and 25,000 of the Reported Shares are held by the Hodges Pure Contrarian Fund, all of which are series of Professionally Managed Portfolios, an investment company registered under the Investment Company Act of 1940. The investment adviser to all of these funds is HCM, which may be deemed to be a beneficial owner of the funds' Reported Shares.
