On the date indicated, Danaher Corporation granted the reporting person restricted stock units (RSUs) in the amount indicated. This filing serves to amend the disclosure set forth in Table 1, Column 5 of the Form 4 filed by the reporting person on April 21, 2017, which reflected the reporting person as beneficially owning 84,800 shares but should have reflected beneficial ownership of 93,053 shares.
