- (1) As part of the Director's compensation, each director receives a retainer of \$9,000.00 semi-annually, 1/3 is paid in cash, and 2/3 in GLT stock. These shares represent the stock portion of this retainer.
On August 4, 2003, Mr. DeBenedictis accrued these phantom shares under P. H. Glatfelter's Deferred Compensation Plan for Directors.
- (2) They should have been entered in table II as a derivative, not in table I as a non-derivative. The footnote at the time did indicate they were phantom shares.
- (3) Phantom stock units accrued under the P. H. Glatfelter Deferred Compensation Plan for Directors on deferred quarterly dividend payments of \$.09.
