**Item 8.01 Other Events**

*Issuance of 2.00 Billion of Notes*

On July 10, 2013, Oracle Corporation ( Oracle ) consummated the issuance and sale of 1,250,000,000 principal amount of its 2.250% Notes due 2021 and 750,000,000 principal amount of its 3.125% Notes due 2025 (collectively, the Notes ), pursuant to an underwriting agreement dated July 2, 2013 among Oracle and BNP Paribas, Deutsche Bank AG, London Branch and The Royal Bank of Scotland plc. The Notes will be issued pursuant to an Indenture dated as of January 13, 2006 (the Indenture ) among Oracle (formerly known as Ozark Holding Inc.), Oracle Systems Corporation (formerly known as Oracle Corporation) and Citibank, N.A., as amended by the First Supplemental Indenture dated as of May 9, 2007 (the First Supplemental Indenture ) among Oracle, Citibank, N.A. and The Bank of New York Mellon Trust Company, N.A. (formerly known as The Bank of New York Trust Company, N.A.), as trustee, and an officers certificate issued pursuant thereto.

The Notes are being offered pursuant to Oracle s Registration Statement on Form S-3 filed on April 15, 2013 (Reg. No. 333-187919), including the prospectus contained therein (the Registration Statement ), and a related preliminary prospectus supplement dated July 2, 2013 and a prospectus supplement dated July 2, 2013.

The material terms and conditions of the Notes are set forth in the Form of Officers Certificate filed herewith as Exhibit 4.11 and incorporated by reference herein and in the Indenture filed as Exhibit 10.34 to the Current Report on Form 8-K filed by Oracle Systems Corporation on January 20, 2006, and the First Supplemental Indenture filed as Exhibit 4.3 to the Registration Statement on Form S-3 filed by Oracle Corporation on May 10, 2007.
