#### ATTACHMENT

The Registrant's net income (loss) for the six-month and three-month periods ended November 30, 2014 is expected to be approximately \$(305,379) and \$(658,052), respectively, compared to \$1,572,154 and \$(12,724) for the corresponding periods of the prior year.

The Registrant's net income (loss) available to common stockholders for the six-month and three-month periods ended November 30, 2014 is expected to be approximately \$(581,623), or \$(0.02) per share, and \$(796,121), or \$(0.03) per share, respectively, compared \$1,298,026, or \$0.05 per share, and \$(150,626), or \$(0.01) per share, for the corresponding periods of the prior year.

The decline in net income and net income available to common stockholders for the six-month and three-month periods ended November 30, 2014 compared to the corresponding periods in the prior year is primarily due to a

decrease in sales of approximately \$881,000 and \$436,000, respectively, and a decrease in gross profit of \$1,878,000 and \$1,062,000, respectively.
