 $\$1,000 + (\$1,000 \times \text{the index return} \times \text{the upside participation rate})$, subject to the maximum return at maturity

Payment at maturity:

If the final index level is **less than or equal to** the initial index level:
 $\$1,000 + (\$1,000 \times \text{the index return})$, subject to the minimum payment at maturity

If the final index level depreciates from the initial index level, you will be exposed to the first 5% of that depreciation and your payment at maturity will be less than the stated principal amount per note. If the final index level of the underlying index is less than the initial index level, you will lose 1% of the stated principal amount of the notes for every 1% by which the final index level is less than the initial index level, subject to a maximum loss of 5% of your investment.

Your payment at maturity depends on the closing level of the underlying index on a single day.
