Item 8.01. Other Events.

On March 21, 2006, The Home Depot, Inc. (the Company) entered into an Underwriting Agreement with Morgan Stanley & Co. Incorporated, J.P. Morgan Securities Inc. and Merrill Lynch, Pierce, Fenner & Smith Incorporated for the issuance and sale by the Company of \$1,000,000,000 aggregate principal amount of the Company s 5.20% Senior Notes due 2011 and \$3,000,000,000 aggregate principal amount of the Company s 5.40% Senior Notes due 2016. The Notes due 2011 and the Notes due 2016 were registered under the Securities Act of 1933, as amended, pursuant to a shelf registration statement.

The Underwriting Agreement is attached hereto as Exhibit 1.1. The Form of Note due 2011 and the Form of Note due 2016 are attached hereto as Exhibit 4.1 and Exhibit 4.2, respectively.
