Clients of ASB have the right to receive and the ultimate power to direct the receipt of dividends from, or the proceeds of the sale of, such securities. First Eagle Value in Biotechnology Master Fund, Ltd. ("FEVBM"), a Cayman Islands company for which ASB acts as investment adviser, may be deemed to beneficially own 3,198,624 of these 8,064,005 shares, which equates to 5.81% of the Common Stock.
